The Secretary, G.R.D. College of Pharmacy, Thiruvallur District has submitted an application and requested the University to issue Consent of Affiliation for starting *M.Pharm.(Pharmaceutics and Pharmacology) Degree course* for the academic year 2024 - 2025 vide reference 1st cited. The said application was not accompanied by the G.O.(Essentiality Certificate). Hence, an application and the relevant documents had been returned to the said college on 02.02.2024 due to non submission of the Government orders vide reference 2nd cited.

2. Again, the Secretary of the said College has requested to issue Letter of Consent of Affiliation to start M.Pharm. Degree Course vide ref. 3rd cited alongwith the Orders of the Hon'ble High Court of Madras in the reference 4th cited. Based on the W.P. Nos. 4369, 4372 & 4373 of 2024,

dated: 22.03.2024, an Inspection was conducted on 22.04.2024, **without prejudice to the rights of this University to appeal against the Court Order dated 22.03.2024 passed in the said W.P. Nos. and subject to outcome of writ appeal to be filed before the Hon'ble Divisional Bench of Madras, High Court** by this University and as per the Statutes No. 42 of the Tamil Nadu Dr. M.G.R. Medical University (Affiliation of Pharmacy Colleges) Statutes, the University issues the Consent of Affiliation (in Form-II annexed) to G.R.D. College of Pharmacy, Thiruvallur District, to start M.Pharmacy Degree Course with two branches viz. Pharmaceutics and Pharmacology.

3. You are instructed not to admit any student in the above said branches in M.Pharmacy Degree course till the Provisional Affiliation Order is granted by this University. You are also instructed not to advertise through any media or in any form in this regard. You are further informed that the students admitted before the issue of Provisional Affiliation orders will not be registered by this University.

4. I am to request you to submit the Form – III along with the copy of the approval of the Pharmacy Council of India, New Delhi with Branch wise intake.
